22 July 2014 and 3 December 2014	Committee and Scrutiny Support Officer to contact Meals on Wheels to see if there were further opportunities for councillors to accompany them on deliveries. Also, to contact Inspector Lillitou to ascertain whether it was viable for PCSO's to accompany Members on deliveries.	Committee and Scrutiny Support Officer	Hertfordshire Community Meals would be delighted to host as many Councillors as want to come. Watford clients are served from the Hemel Hempstead site at 17 Hammer Lane, Hemel Hempstead, HP2 4EU. It is recommended that Members come to this site to see the pre-delivery operation (meet the Customer Service Team and see the kitchen in action) and to meet a member of the Senior Leadership Team and learn more about the services which are delivered. They could accommodate up to four Councillors on any one day (as they have four delivery rounds in the Watford area – and they presume Councillors would prefer to go out on delivery rounds in their own area). They operate 365 days a year, so if WBC could let them know some dates, they can arrange. It would be easier for Hertfordshire Community Meals to manage if one

			central person from WBC were to organise this with Lizzie Hopkinson (Executive Assistant to our Chief Executive) on behalf of all the Councillors. That way they could ensure that the maximum number they can accommodate on any one day is not exceeded, and ensure that a member of our Senior Leadership Team would be there to meet them With regard to PCSOs accompanying Councillors as well. Unfortunately, due to the size of Hertfordshire Community Meals vehicles and the amount of hot boxes they have containing food, they would only able to accommodate one passenger at a time.

Inspector Lillitou	The Neighbourhood Watch messages are sent out and the Sergeants and Inspector Lillitou dip-sample and monitor these. Therefore there wouldn't necessarily be a specific message from a co-ordinator, unless there was a specific issue within the road in which they operate. A New Watch Liaison Officer has now been appointed

			for the Watford area, Patrick Beynon. He will be located centrally at HQ in Welwyn Garden City and Inspector Lillitou will be looking at how to improve interaction with the co-ordinators as they continue to grow Neighbourhood Watch across Watford via the Safer Streets campaign.

Inspector Lillitou	As the changes to the recording procedures only took place in July 2014, meaningful data will be unlikely to be available until April 2015.
