#### SUMMARY

# DETAILED PROPOSALS, REPRESENTATIONS AND RECOMMENDATIONS

The following report has been compiled on a scheme by scheme basis for ease of use, the relevant plans can be found in Appendix A:

### 1.1 Miscellaneous 1

### 1.1.1 SK02-01

**Location:** Warneford Place, King Edward Road, Chalk Hill.

Plan: 1000002707-2-SK02-01

**Statement of reasons**: To prevent obstructive parking that narrows the road and impedes traffic flow and blocks access to pedestrian crossings. **Proposition**:

- Chalk Hill Introduction of 'No waiting, Mon Sat, 8am 6.30pm'.
- King Edward Road / Warneford Place Introduction of 'No Waiting at any time' restrictions.

# Representations:

- Warneford Place/King Edward Road (would limit parking which is already scarce in the area. Suggestion of a permit scheme to ensure parking for residents.)
- Agrees in full with other representation.
- Warneford Place DYLs would further reduce high stress parking availability.
- Fully in favour of scheme.

**PCL recommendation**: Implement scheme. Any decision to implement a permit scheme should be considered separately.

**WBC decision**: Shorten the 'no waiting at any time' lines to only cover the drop kerbs.

Statement of reasons: To prevent obstructive parking blocking access to the

Pheasant Court retirement complex.

**Proposition:** Introduction of 'No waiting at any time' lines.

## Representations:

• Fully against scheme.

**PCL recommendation:** Reduce scheme to just allow ease of access for emergency and refuse vehicles.

**WBC decision**: Shorten 'No waiting at any time' lines as per PCL recommendations.

**PCL recommendation:** Implement scheme ensuring that two parking spaces are available outside 59 & 61 Kingsfield Road. Reduce section by 0.5m.

**WBC decision**: Shorten 'No waiting at any time' lines as per PCL recommendations.

**Statement of reasons:** To maintain driver sightlines and prevent obstructive

parking impeding access to property number 388 & 400. **Proposition:** Introduction of 'No waiting at any time' lines.

Desire for a permit scheme along St Albans Road.

**PCL recommendation:** Implement scheme. Consider permit scheme at a future date.

WBC decision: Implement scheme.

Statement of reasons: To prevent obstructive parking that narrows the road and

impedes traffic flow.

**Proposition:** Introduction of 'No waiting at any time' lines.

# Representations:

• In favour however extend to include parking space between 2a & 2b.

- Switch DYLs to other side of the road due to the relative availability of off street parking.
- Fully against scheme having lived there for 24 years.
- Fully against scheme, 10m junction protection at Hempstead Road or permit scheme would be preferable.

**PCL recommendation:** Amend scheme. Implement 10-20m junction protection at Hempstead Road.

**WBC decision**: Implement scheme as per PCL recommendations.

**Statement of reasons:** To ensure access to off street parking, provide

protection to the bend of Percy Road and to provide further off street parking

# Representations:

• Concern that permit bay extension would make Percy Court inaccessible for refuse vehicles.

• Fully against scheme. Veolia would not be able to perform refuse duties.

**PCL recommendation:** Amend scheme. Reduce permit bay extension to the eastern wall of No. 6 & 7 Percy Court.

**WBC decision**: Scheme amended as per PCL recommendations.

  permit scheme or bay parking would be appropriate.
- Perhaps day time single yellow lines would be more appropriate as parking availability is already limited. Fleet of Medivet vehicles from Sandown Road limit available parking.
- Fully against scheme.
- Change 5m junction protection lines to 4m or 2m in order to preserve the limited parking availability.
- Fully against scheme.
- Fully against scheme.

**PCL recommendation:** Representations suggest that scheme is not well received due to the high parking stress associated with the road. No response from separate Councillor emails. Remove the junction protection lines and keep the line outside No. 11 to ensure access for emergency and refuse vehicles.

- Fully in agreement with other representation.


