INTRODUCTION

Aim and purpose:

The aim of the annual Strategic Assessment for Watford Community Safety Partnership (CSP) is to outline current crime and disorder issues and to identify emerging trends to inform the preparation of an annual Community Safety Action Plan, which the partnership aims to deliver through the processes defined in a rolling three-year Community Safety Plan. This will ensure that Watford Community Safety Partnership has a detailed understanding of crime and disorder issues, allowing for informed problem solving tactics to take place in line with the priorities this document outlines.

Demographics:

The rounded Census 2011 figures give Watford a population of 90,300, and 36,700 households. Covering 2,142 hectares (8.3 square miles) Watford is the most densely populated district council in England. As the only non-metropolitan borough wholly contained within the M25, it is the centre of a sub-region serving 500,000 people who live within 20 minutes travelling time. The main shopping centre, retail parks, hotels and car parks are all located within close proximity of one another in central Watford.

The Borough is the fifth best connected district in the country, with direct mainline rail connections to London, Midlands and the North, under ground connections to London and key road connections via the M1, M25 and A41.

Watford's close proximity to London brings the influence and benefits of a buoyant economy, making it a sought after place for accommodation, work and tourism. However, this adds significant pressure on available land for development thus increasing prices on available commercial and housing stock.

Population:

An age breakdown of the Community Safety Partnership is illustrated in the table below, taken from the rounded 2011 Census figures.

Ethnicity:

Ethnicity data has just been released from Census 2011. It shows a changed picture for Watford, summarised as:-

Overall, the British White population is now 61.9% from 79% in 2001 (although estimates since 2001 had indicated a fall from the 2001 level this was a higher fall than predicted).

In real terms the British White population has fallen from 63,082 to 55,875, although our population has increased.

Other noticeable changes are:

- the percentage increase in Other White from 2.1% (3,140 residents) to 7.7% (6,947 residents) although the figure is not broken down any further this reflects what we have experienced in terms of the increase in residents from Europe particularly Eastern Europe
- the percentage increase in Indian residents up from 2.4% (1,884) to 5.5% (4,923)
- the percentage increase in Pakistani residents up from 4.6% (3,709) to 5.5% (6,082)
- the percentage increase in Black African residents up from 1.0% (784) to 3.5% (3,142)

Visitors:

Footfall figures of the night time economy highlight on average there are 2,000-4,000 visitors on Friday nights and 3,000-6,000 on Saturdays. At seasonal peaks these figures may increase with people visiting the town centre pubs and clubs.

Footfall figures of The Harlequin Centre also highlight the volumes of people visiting Watford, with approximately 16 million visitors to the Harlequin Centre each year. Most weeks the shopping centre experiences 200,000 visitors and on average 30,000 a day. During busy periods such as Christmas and Easter the Harlequin Centre sees an increase and approximately 500,000 visitors each week. Watford Football Club in Vicarage ward has a capacity of 20,000.

Both the Police Station in Central ward and Hospital in Vicarage ward serve not only the town but also the surrounding areas and therefore can skew 'per head' calculations.

Employment:

Summary of data on unemployment shows that the claimant count for Jobseekers Allowance in Watford for July 2012 (1,816) is still broadly level with the figures from July 2011 (1,773). The proportion of Watford's resident working age population claiming jobseekers allowance at July 2012 is 3.1%. A higher percentage of 18-24 year olds are unemployed however and for this age group the percentage is 5.9%(430).

IQuanta family groups and in county comparison:

From iQuanta data most similar group comparisons are made between Watford and the 14 other most similar Community Safety Partnerships nationally, and are based on comparisons made in the 12 months up to 31 July 2012. Watford's most similar group includes: Bracknell Forest (Thames Valley), Bristol (Avon & Somerset), Crawley (Sussex), Hounslow (Metropolitan Police), Kingston upon Thames (Metropolitan Police), Northampton (Northamptonshire), Poole (Dorset), Reading (Thames Valley), Rushmoor (Hampshire), Slough (Thames Valley), Stockport (Greater Manchester), Trafford (Greater Manchester), Woking (Surrey), and Worthing (Sussex).

Comparisons within the county are between all 10 Community Safety Partnerships in Hertfordshire. For both most similar group and in county comparison 1^{st} place reflects the lowest rate per 1000 population or count, depending on the indicator



Watford has generated a medium risk assessment for burglary dwelling, which is no change when compared to the previous year. As the table above illustrates there were 361 dwelling burglary offences recorded in the period, which included 68 attempts, 19 distractions and 1 aggravated. This is a 4.5% decrease from 378 offences the previous year, 54 of which were attempts, 8 distractions and 2 aggravated. When compared with the rest of the county Watford is ranked highest for burglary dwelling $(10^{th}/10)$, which is an increase from $9^{th}/10$ position the previous year.

IQuanta data reflects Watford as 9th/15 in comparison of its most similar group, which is no change when compared to the previous year. Watford has reported 10.86 offences per 1000 households and the average for the most similar group is 11.62 crimes per 1000 households. The Community Safety Partnership has continued to perform in line with its peers and better than the most similar group average.


A low risk assessment has been generated for vehicle crime, compared to a medium risk from a local knowledge assessment the previous year. During the 12 month period as shown in the table above there were 528 offences recorded. This is a 22.6% decrease when compared to 682 offences the previous year.

Watford is $7^{th}/10$ in county position for vehicle crime, which is an improvement compared to $8^{th}/10$ the previous year. IQuanta data reflects the Community Safety Partnership as $7^{th}/15$ in its most similar group, reporting 6.14 offences per 1000 residents. This is also an improvement in position compared to $11^{th}/15$ the previous year. Over the 12 months assessed the average for the most similar group was 7.33 crimes per 1000 residents. Watford has recorded a lower rate of offences than this average.

Theft from motor vehicle offences account for 76.5% of vehicle crime recorded (excluding interference). These offences have decreased by 24.8%, from 537 in the

previous year to 404 in the current period. Levels of vehicle taking including attempts have also decreased (down 22 offences); from 136 to 114 offences. However, aggravated vehicle taking offences have increased (up 1 offence); from 9 to 10.

Watford has generated a medium risk assessment for theft from person offences. This is an improvement compared to a high risk the previous year. During the 12 month period 441 offences were recorded, which is a 21.7% decrease when compared to 563 offences the previous year. Watford Community Safety Partnership is ranked highest in county (10th/10), which is no change when compared to the most recent financial year (ending March 2012), and previous strategic period (ending July 2012).

Watford is also highest in comparison of its most similar group (15th/15) and has reported 5.15 crimes per 1000 residents. The average for the most similar group is 1.90 crimes per 1000 residents, with Watford recording a considerably higher rate of offences.

Watford has generated a medium risk assessment for violent crime. Levels of violent crime have increased by 12.7% when compared to the previous year; 1539 violent crime offences were recorded compared to 1365. Watford Central (C1A) continues to be the top beat accounting for 46.3% of the total (713 offences).

Watford is ranked second highest in county position (9th/10) for violent crime. When compared to the previous year, this is no change in position. IQuanta data reflects the Community Safety Partnership as 8th/15 in its most similar group; reporting 17.81 crimes per 1000 residents. This is an increase in position when compared to 6th/15 the previous year. During the 12 months assessed Watford has recorded a slightly lower rate than the most similar group average of 17.91 crimes per 1000 residents.

The number of notifiable offences recorded and flagged with an aggravating factor of domestic violence have increased in Watford, when compared to the previous year; from 291 offences to 324. 85.5% of offences were of a violent nature during the current period, compared to 83.2% the year before. Watford Community Safety Partnership is 7th/10 in county for offences recorded per 1000 population; recording 3.59 crimes per 1000 residents. The number of non-crime domestic incidents recorded are shown to have decreased, from 942 in the previous year to 916 in the current period.

2) Hate Crime

For the purpose of this assessment race and religious hate crime offences, are those offences which have an offence description of racial / religious or an aggravating factor of racial/religious flagged.

There were 97 notifiable race and religious hate crime offences recorded during the period, which is a 9.3% decrease from 107 offences the previous year. Hate crime is not currently recorded on iQuanta. Watford is highest in county ($10^{th}/10$) for race and religious hate crime reporting 1.074 offences per 1000 population. This could however

be seen as a positive reflection on local police being vigilant, in recording racially or religiously aggravated crime. Given that Watford has one of the most diverse and densely packed populations in the county, this could in itself skew local comparisons.

Watford recorded 6 notifiable offences with homophobic or transphobic flagged as an aggravating factor, this is an increase compared to no notifiable offences the previous year. Levels of offences recorded remain low indicating a need to continue to look for ways to encourage willingness to report. In relation to disability hate crime (including physical, sensory and learning) Watford recorded 19 notifiable offences, which is an increase compared to 15 the previous year. These figures should however be treated with caution, as the data set is not based on mandatory collection and may therefore be incomplete.

- Police Domestic Abuse Officer attends Anti Social Behaviour Group (ASBAG)
 which has supported a more 'joined up' approach to tackling DV
- Development & support of the Watford & Three River Domestic Abuse Forum
- Actively engaged with the introduction of Thinking Families & Counter Terrorism & Domestic Extremism Group
- Youth Projects run by Youth Connexions address key issues of relevance to young people to reduce harm to themselves and others and also to encourage cultural awareness and tolerance. Over the past year, these have included topics on: cyber and other bullying; celebration of cultures and reporting crime including use of fearless.org (part of crimestoppers uk).

Alcohol-related crime

Alcohol related crime is not currently recorded on iQuanta. There were 876 alcohol related offences recorded during the 12 month period. This is a slight increase of 0.6% from 871 offences the previous year (ending July 2011). In comparison last year's assessment recorded a 17.5% decrease in offences. For the purpose of these figures, incidents where alcohol is recorded as a factor are considered to be alcohol-related.

Watford is currently highest in county (10th/10), reporting 9.70 crimes per 1000 population. This is no change in county position when compared to the previous year.



During the 12 months assessed (to the end of July 2012) levels of ASB recorded by the police have decreased in Watford by 16.8%. As shown in the above table 5000 incidents were recorded compared to 6013 the previous year. The Community Safety Partnership is currently highest in county for ASB (10th/10), reporting 55.37 incidents per 1000 population.

Whilst ASB has greatly reduced a proactive approach and continued development of partnership working is required to effectively develop new effective approaches to tackling ASB. Criminal damage is seen as ASB by the public, so it is recommended that criminal damage is included as part of ASB but targets remain separated to reflect the police category of 'crime other'.



Watford has generated a low risk for criminal damage, compared to a medium risk previously. The Community Safety Partnership has recorded a 12.9% decrease in criminal damage offences. 825 offences were recorded in the current period, compared to 947 the previous year. The most prevalent offence type within the category of 'criminal damage' was found to be vehicle damage, accounting for 48.6% of the total (401 offences). The Community Safety Partnership remains 8th/10 in county position for criminal damage.

Watford is currently 4th/10 in county for deliberate fire calls, reporting 1.0 call per 1000 population. The number of deliberate fire calls have decreased from 128 in the previous year to 87 in the current period. Refuse /rubbish tip/ wheelie bin/skip is the highest sub category (28 incidents), followed by Tree/Scrub and Car/Van (7 incidents

each). Watford Central (C1A) is the top beat recording 18 calls, which is a decrease compared to 30 the previous year. Meriden (C4E) which was the second highest beat also recorded a decrease, from 18 calls in the previous year to 15 in the current period. Whilst there was an overall decrease the following three wards recorded slight increases: Callowland (C4A), Park (C1G) and Tudor (C4F).

 Youth Worker teams also go out to areas where large numbers of young
 people are congregating. Successful diversionary programmes were
 organised especially for key times such as Halloween and bonfire night
- Through partnership working with Joint Action group (JAG) and ASBAG reducing deliberate fires to their lowest recorded level.

Integrated Offender Management

Hertfordshire has been working within the Integrated Offender Management (IOM) Scheme to manage Priority Prolific Offenders (PPO) since April 2011. A scoring matrix designed to identify the top 200 offenders; those who commit high levels of acquisitive offences utilises police, probation and youth offending data. The scheme was launched in April 2011 and has led to greater partnership working. At the time of writing there are currently 192 PPOs adopted under the IOM Scheme in Hertfordshire.

Hertfordshire Police maintain the lead for one of the PPO strands, 'Catch and Convict' however police offender managers now work even more closely with Hertfordshire Probation Trust on the 'Rehabilitate and Resettle' strand, with a shared aim to break the cycle of offending and to permanently rehabilitate offenders. The partnership includes Probation, the Choices and Consequences (C2) Programme, Hertfordshire County Council, Health, Crime Reduction Initiative (CRI) drugs services, Hertfordshire Association for the Care and Resettlement of Offenders (HACRO) and third sector agencies all working within the IOM Hertfordshire Horizons PPO scheme; these together make a significant impact on reducing offending and rehabilitating offenders and continue to drive forward a number of interventions which to date have had impressive results on the reduction of offending.

As at the end of quarter one (1st of April 2012 to 30th of June 2012) Watford Community Safety Partnership has 22 PPOs adopted under the IOM scheme. When compared to the same quarter the previous year, the number of detected offences committed by these PPOs have decreased by 16; from 28 to 12. Additionally the number of PPOs committing offences have also decreased from 10 to 6. Watford is ranked 7th/10 for the number of PPOs in the IOM cohort. Whilst a decrease has been noted this highlights a continued need for Integrated Offender Management in Watford.

Youth Offending

Data provided by Hertfordshire County Council's Targeted Youth Support Services records 170 youth offences in the Community Safety Partnership, during the strategic period. This places Watford $6^{th}/10$ within Hertfordshire. To confirm - a youth offence is defined in the above as an offence with a substantive outcome for example Police Reprimand, Final Warning, Community Penalty given at court or a Custodial sentence. For the number of youth offenders Watford stands $2^{nd}/10$ in the county with 73 offenders for the same period.

Probation (including Community Payback)

Watford had 279 unique clients on the probation caseload during the 12 month period. This places the Community Safety Partnership $6^{th}/10$ in county position. Watford currently stands $5^{th}/10$ within Hertfordshire for the number of unique clients taken on to the probation caseload with an unpaid work order; 101 unique clients for the same 12 month period.

Watford Borough Council work closely with Probation in hosting Community Payback reparations on a weekly schedule. Works include litter picking, cleaning graffiti and ground clearance.

During the period 1st July – 30th September 2012, a total of 8379 hours work in the community in the Western Area. The total consists of 1816 hours worked on Individual Placements, and 6563 hours of Community Payback group working, within the Watford Area 4540 hours were worked, including;

- Data on re-offending cohorts on Local Delivery Unit and Centre (Watford)
 have highlighted the main issues concern alcohol and drug misuse with a link
 to anti-social behaviour and to a less extent domestic violence, a working
 group is being set up to examine brief interventions.
- Drug Rehabilitation Requirement and Alcohol Treatment Requirement Provision is above target. The process has been revised and now delivering above target.
- Single points of contact are in place.
- Anne Frank Diversity Group is now up and running, working extremely well with positive feedback.
- The Integrated Offender Management report is showing success, with a reduction in re-offending.
