Title: Council Tax 2009/10

Reason for Urgency: The County Council and the Police Authority did not set their precepts until 24th and 20th February respectively. The overall level of council tax needs to be approved to comply with legal and good practice requirements on billing.

1.0 **SUMMARY**

1.1 This report consolidates the decisions of this council and the two precepting authorities to give the overall council tax for residents of Watford for the coming financial year.

2.0 **RECOMMENDATION**

2.1 That the Committee formally sets the total council tax for Watford Borough Council, including the precepts for Hertfordshire County Council and the Hertfordshire Police Authority, as set out in the report in Table 3.

3.0 **DETAILED PROPOSAL**

- 3.1 Council approved the budget and council tax for Watford's Borough Council's own purposes on 4th February 2009. The Hertfordshire Police Authority and Hertfordshire County Council have now set their precepts. The Committee is now required to formally set the total council tax for all three authorities.
- 3.2 The figures for all council tax bands for each authority are set out below, together with the combined figure.
