**1.0 Summary**

1.1 This report recommends the appointment of Tom Dobrashian Executive Director of Place for Watford Borough Council, effective from 1 August 2022.

**4.0 Detailed proposal**

4.1 Following the decision of Cabinet on 13 June 2022 approving the restructuring of the senior management of the council and the introduction of new Executive Director roles, an internal recruitment process was instigated to identify an Executive Director of Place.

4.2 The Appointments and Disciplinary Committee undertook an interview on 5 July 2022. The cross-party committee comprised:

Cllr Mark Watkin (Chair)  
Cllr Jagtar Singh Dhindsa  
Cllr Kennedy Rodrigues  
Cllr Ann Saffery.

It was unanimously agreed that Tom Dobrashian should be offered the role, subject to final approval by full Council.

4.3 In accordance with the Constitution, the council's Monitoring Officer subsequent to the Committee's recommendation, formally notified the Executive of the proposal and requested that any concerns about this proposed appointment were notified to her or the Executive Head of HR in writing within 3 working days i.e. by no later than 5 pm on 12 July 2022. No concerns were raised and therefore council is asked to endorse the appointment of Tom Dobrashian as Executive Director of Place.
