1.0 SUMMARY

1.1 This report consolidates the decisions of this Council and the two precepting bodies to give the overall Council Tax for residents of Watford for the coming financial year.

2.0 RECOMMENDATION

2.1 That the Committee formally sets the total Council Tax for Watford Borough Council, including the precepts for Hertfordshire County Council and the Police and Crime Commissioner for Hertfordshire, as set out in the report in Table 3.

3.0 DETAILED PROPOSAL

3.1 Council approved the budget and Council Tax for Watford Borough Council's own purposes on 30th January 2013. The Police & Crime Commissioner for Hertfordshire and Hertfordshire County Council have now set their precepts.

The Committee is required to formally set the total Council Tax for all three bodies.

3.2 The figures for all Council Tax bands for each body are set out below, together with the combined figure.

3.4 Please note that the Police and Crime Commissioner for Hertfordshire agreed a zero increase in its precept requirement at its meeting on 24th January 2013. Hertfordshire County Council will not agree its precept requirement until 26th February although it is anticipated that a zero increase will be approved. This report has therefore been prepared on that basis. In the unlikely event that HCC make an alternative decision then a supplementary report would be required. The final precepts in the above table, represent no increase compared to last year by any of the constituent authorities.
