### 1.0 SUMMARY

1.1 An application for a new premises licence has been received from Tesco Stores Ltd for Unit A, 1 Colnhurst Road, Watford, WD17 4BU. Twenty eight valid representations have been received from local residents as interested parties. Two are in support of the application, two have subsequently been withdrawn leaving twenty-four objecting to the application.

6.9 The recurring themes throughout the representations is regarding the potential for public nuisance caused by the hours applied for and the potential for individuals with drink problems to be attracted to the area and the issues associated with that.

### 7.0 **Policy considerations**

- 7.1 The following provisions of the Licensing Act 2003 apply to this application:
  - Sections 17 and 18 (Application for a premises licence): Section 17 details the process which the applicant must have followed for the application to be considered valid. Section 18 describes the process by which an application for a premises licence is determined, including where relevant representations have been made as in this case.
  - Section 19 (Mandatory conditions): Section 19 details the mandatory conditions that would apply if the sub-committee was minded to grant a licence authorising the supply of alcohol.
  - The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 This Order adds a mandatory condition regarding the requirement for an age verification policy to any licence or certificate that authorises

the supply of alcohol.

### 7.2 <u>Statutory guidance</u>

The following provisions of the Secretary of State's guidance apply to this application:

• Paragraphs 8.34 - 8.42:

These paragraphs explain how steps should be taken to promote the licensing objectives. It is for the Sub-Committee to decide in light of this guidance whether the measures offered by the applicant are adequate and likely to promote the licensing objectives. It is equally important to use the same measure when looking at any steps requested by a party making representation against an application.

• Chapter 10:

This chapter looks at best practice in relation to conditions that may be attached to a premises licence by the Sub-Committee, should they believe that these are necessary to promote the licensing objectives. Any additional conditions requested by the responsible authorities should be considered with reference to this chapter.

Paragraph 10.13 states 'Shops, stores and supermarkets should normally be free to provide sales of alcohol for consumption off the premises at any times when the retail outlet is open for shopping unless there are good reasons, based on the licensing objectives, for restricting the hours.

### 7.3 <u>Statement of licensing policy</u>

The following paragraphs of the licensing authority's statement of licensing policy apply to this application:

 Policy LP1 (Premises Definitions): Under this policy the premises, if licensed, would be defined as a "Offlicence".

The sale of alcohol for consumption away from the premises.

• Policy LP2 (Location and Operation of Premises): This policy sets out the approach to licensing premises when relevant representations are received, not withstanding that each application is considered on its own merits.

Off-licences in a residential area will generally be allowed alcohol sales in accordance with the normal opening hours of the premises

• Policy LP6 (Prevention of Crime and Disorder): Although the applicant has not provided any evidence that a crime prevention audit has been carried out at the premises as suggested by this policy, the applicant's operating schedule was submitted after consultation with the police who have not made any representations. This policy details the factors that will be considered when a relevant representation is received based on this licensing objective.

- Policy LP8 (Prevention of Public Nuisance) Under this policy the committee will consider any necessary measures to deal with the potential for public nuisance and/or anti-social behaviour where relevant representations have been received.
- Policy LP9 (Protection of children from Harm): Under this policy the committee will consider any necessary measures to deal with the potential for children to be harmed as a result of the proposed licensable activities where relevant representations have been received.
- Policy LP11 (Representations against Applications) This policy recommends the type of information that should be included in a representation. It also explains how representations will be dealt with.
- 7.4 The Committee is reminded of their duty under the Crime and Disorder Act 1998 to consider the crime and disorder implications of their decisions and the authority's responsibility to co-operate in the reduction of crime and disorder in the Borough.
- 7.5 The Committee is reminded that the Human Rights Act 1998 guarantees the right to a fair hearing for all parties in the determination of their civil rights. The Act also provides for the protection of property, which may include licences in existence, and the protection of private and family life.

### 8.0 RELEVANT TRADE OR OTHER GUIDANCE None

### 9.0 CONDITIONS

9.1 Members will be aware that an operating schedule forms part of the licensing application process. This document outlines what activities are proposed, the opening hours, how the activities will be managed particularly in respect of the licensing objectives.

The most critical part of the operating schedule is the steps taken by the applicant to promote the four licensing objectives. Applicants are always recommended to take careful consideration as to what is entered in this section as whatever is proposed will be translated as conditions on the licence.

Applicants should give consideration to the local area and reflect this in their application. It should demonstrate an awareness of the local community,

local crime and disorder issues, and environment.

All of the conditions that would appear on any granted premises licence can be found on the draft licence at appendix 5.

- 9.2 <u>Consistency with operating schedule</u> The applicant has provided a detailed operating schedule (appendix 3) which, if the application is granted, would be translated into licence conditions.
- 9.3 <u>Conditions proposed by the responsible authorities</u> Following discussions with the Police the applicant has agreed to have the following condition attached to any granted premises licence:

There will be no sales of any beer, cider or lager in bottles, cans or any other form of container that has a strength of over 5.5% abv (alcohol by volume).

9.4 <u>Conditions proposed by interested parties</u> Not applicable.

### 9.5 <u>Pool of Model Conditions</u>

The licensing authority also has its own pool of model conditions and the condition agreed with the Police was taken from this. Officers would suggest that the first two conditions could be attached to the premises licence, if granted, to help mitigate concerns regarding the premises attracting street drinkers. Condition 3 is suggested as a way to try and mitigate nuisance from customers leaving the premises.

- 1. No single cans or bottles of beer, lager or cider shall be sold at the premises.
- 2. There shall be no self-service of spirits on the premises.
- 3. A minimum of three notices must be displayed in the windows of the premises which state 'Customers are requested to park responsibly and respect our neighbours by leaving the area quietly'. These notices must not be smaller than A3 in size and in a font size clearly legible from the 16 parking bays immediately surrounding the premises.

This does not restrict the Sub-Committee's power to attach conditions from the pool (amended or otherwise) if they consider that they are appropriate, proportionate, justifiable and within the applicant's power to comply with.

### 10.0 **OFFICERS' OBSERVATIONS**

10.1 With the exception of two representations received in support of the application all the interested parties mention the hours applied for as being an issue. The main concern appears to be that the hours will potentially attract street drinkers in to the area and the effect this could have on local residents and particularly children. This is an overarching theme from the

objectors and potentially links in to all of the licensing objectives.

- 10.2 The applicant appears to have partially addressed these concerns with the condition agreed with the Police which prohibits the store from selling the types of alcohol street drinkers are known to prefer. This resulted in the Police not making a representation against the application.
- 10.3 Paragraph 9.12 of the section 182 guidance states that 'In their role as a responsible authority, the police are an essential source of advice and information on the impact and potential impact of licensable activities, particularly on the crime and disorder objective' and 'The police should be the licensing authority's main source of advice on matters relating to the promotion of the crime and disorder licensing objective'. Members must attach the weight they see appropriate to the fears of potential crime and disorder detailed in the representations in light of the police decision to not make representations.
- 10.4 A number of representations state that they believe that the only people likely to buy alcohol from 06:00 or after 22:00 would be street drinkers or those who abuse alcohol. Members may seek clarification from the applicant regarding the reasons for the hours applied for. The applicant may be able to supply details of similar stores operating at similar hours and the type of clientele that the premises attracts.
- 10.5 Members may wish to question the applicant with regards to their internal procedures and policies for dealing with the issues of street drinkers. As with such a large number of premises nationwide it is highly likely that the issue has been encountered before. Many of the potential issues detailed in the representations are only likely to occur if alcohol is retailed or used in an irresponsible way. The latter point is a matter of personal responsibility and beyond the applicant's control if they have taken all the appropriate steps.
- 10.6 The hours suggested in the representations vary widely but most indicate that a start time of 09:00, after children are in school, would be more appropriate for a premises in this location. The suggested time for the premises to stop selling alcohol is 22:00 although only many interested parties have suggested that shorter hours would be more appropriate on a Sunday.
- 10.7 Watford Borough Council's Licensing Policy (dated January 2011) states at Policy LP2 that off-licences in residential areas will generally be allowed alcohol sales in accordance with the normal opening hours of the shop.
- 10.8 This reflects paragraph 10.13 in the amended guidance issued under section 182 of the Licensing Act 2003.
- 10.9 Neither the Licensing Policy nor the 182 Guidance is binding on the Sub-Committee, however, both must be considered when coming to a decision. The option to restrict the hours for the sale of alcohol is open to Members but there must be good reasons, based on the licensing objectives, for doing

so. Any such reasons should be detailed as part of the decision.

- 10.10 In a number of representations issues are raised that may not fall directly under the control of the applicant. Many of these issues will potentially arise whether the premises is granted a licensed to sell alcohol or not. Issues such as parking, litter, etc should be considered as matters of personal responsibility and the extent to which the applicant can control this is limited. Some of these issues are already occurring, despite the premises not having opened yet, so it may not be appropriate to seek to make addressing them the applicant's sole responsibility. Equally, such measures may prove hard to enforce so may be of limited benefit.
- 10.11 Officers would suggest that if Members believe that there is the potential for any of the licensing objectives to be undermined by granting the application then the starting point should be to look at appropriate conditions to mitigate these concerns.
- 10.12 Some of the representations refer to whether there is a need for this application. The Sub-Committee will know that paragraph 13.18 of the Amended Guidance issued under section 182 of the Licensing Act 2003 makes the question of demand for a premises an irrelevant consideration to take into account.
- 10.13 The officers' observations and the comments regarding the representations are in no way meant to bind Members. They are for guidance only and Members may attach whatever weight they see fit.





LICENSING OBJECTIVES

Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b,c,d,e)

List here steps you will take to promote all four licensing objectives together.

We are a national retailer that sells alcohol as part of a broad offering of goods and services. We have held off-licences in our stores for many years and are an approved British Institute of Inn-keeping examination centre. We have written training policies and formal training programmes are in place, which ensure our people are equipped to meet all licensing objectives. All training and revision/refresher materials are reviewed regularly. All stores currently comply with our 'Think 25' policy, this is brought to customer's attention through point of sale material within the store. We take legal compliance very seriously and in addition to local training we employ a central alcohol licensing compliance manager and have a compliance committee.

b) The prevention of crime and disorder

The premises will have digital CCTV system that covers many areas of the shop floor, including the main area which will be used for beer and wine, should we be successful with our application.

Images will be retained for a minimum of 21 days and made available on enforcement request. Ordinarily, a member of the Management team will be on the premises all the time the store is open. A person will have responsibility for the premises whilst the premises are open.

c) Public safety

A person will have responsibility for the premises whilst the premises are open. Management will be trained to support the running of the premises including looking after our customers and staff. The store will adhere to all rules and regulations relating to public safety.

d) The prevention of public nuisance

We intend to be an active member of the community. We welcome the opportunity to liaise with Police and enforcement authorities should the need arise.

e) The protection of children from harm

All staff will be trained and regularly refreshed in the corporate 'Think 25' Policy. Staff will be trained to look at the customer and 'Think 25' when selling alcohol.

A till prompt will appear on the initial sale of alcohol that will remind the seller of their responsibilities including not to sell alcohol to anyone under the age of 18.

The store will display signage around the premises informing both staff and customers of our 'Think 25' policy on alcohol.

### **Objection to Tesco's request for excessive hours in which to sell alcohol**

I am writing to object to Tesco's request to sell alcohol from 6am through until 11pm at Nascot Grange.

I have real concerns for the amount of time Tesco has requested for based on the following reasons:

- a. Prevention of harm to children
- b. Prevention of public nuisance

### Prevention of harm to children

There is a real risk to children if Tesco is allowed to sell alcohol at the requested hours. Firstly, the store is located opposite a children's playground. There is a high risk that alcohol bought from the store may be consumed in the playground right in front of children. In the long term, this may have a negative influence on the children. Secondly there is a school nearby - Nascotwood school. By selling at these hours the store will likely become a hub for alcohol consumers when children are on their way to school. In fact it is best if the store does NOT sell alcohol.

#### **Prevention of public nuisance**

There will be a high risk that this store located right in the middle of a residential site will attract street drinkers and this will likely cause nuisance and disturbance to local residents.

Based on the above I honestly believe that the Tesco store should NOT sell alcohol or be very limited in its permitted hours of alcohol sale ((10AM - 2PM, Monday to Fridays ONLY).

Dear Sir

I wish to object to the licensing hours proposed by Tesco Express, Nascot Grange. I believe that 6am to 11pm is excessive and will create a public nuisance to our neighbourhood. It will attract street drinkers who will disturb local residents and cause a nuisance in terms of litter, broken bottles etc. The Tesco is situated metres away from a beautiful park which is incredibly popular with children and families (including my own)

I have a very great fear that this park and the surrounding benches will become a street drinkers paradise and that those for whom it was intended will be unable to use it safely.

We object to the licensing of alcohol sale from 6am to 11pm at Tesco Express on the Nascot Grange site for the following reasons:

- 1. To prevent a public nuisance
- 2. Prevention of harm to children

The store is located on a private residential site and will probably attract drinkers who are able to buy alcohol early and late in the day. It will cause a nuisance and disturb residents throughout the day.

It is also a risk to children, because the playground is opposite Tesco (please note that the children play there until 10pm when there is daylight), and it is the council who insisted there be a community playground which is opposite Tesco. It will also certainly increase antisocial behaviour, litter and parking problems in the vicinity causing problems for residents. Many residents would personally feel intimidated coming into contact with someone who has drunk excessively.

Therefore, Mark Watkins has suggested that the licensing should be no longer than 9am to 10pm. However, we would be happier if no alcohol was sold, failing this, even shorter hours, for example, 9am to 9pm would be preferable, bearing in mind that drinking maybe an issue to the later part of the day.

A further issue to consider is that the residents pay for the maintenance of the site to a company called Hazelvine. Who will be responsible for collecting extra cans and bottles as a result of drinkers buying drinks from Tesco? There will also be extra litter from children using the playground (for example, packaging from sweets, fizzy drinks, crisps etc. from Tesco). What responsibility is Tesco taking to deal with any impact their presence will have on a residential site, mainly parking problems and clearing litter caused by the store. Will Tesco provide litter bins outside the store, someone responsible for clearing rubbish and parking restriction signs, for example?

We hope that our concerns will be taken into consideration and we look forward to your reply.

I have recently had the pleasure of purchasing a property at the new Nascot Grange housing development on Colnhurst Road. We were told that instead of having a doctor and dentist surgery we were to have a Tesco Stores LTD. This was good news as it meant we would have a convenience store close by and were looking forward to the proposed bakery to purchase fresh goods.

However, it has come to our attention that the Tesco Stores LTD that is located within the Nascot Grange development would like to sell alcohol from an alarming 06.00am until 11.00pm. We do not object to Tesco Stores LTD selling alcohol, but we do object to the sale of alcohol at the specified times. The sale of alcohol should be limited to the more socially acceptable time of 09.00am until 10.00pm from Monday – Saturday, and on Sunday at normal trading hours of 10.00am to 4.00pm.

If the sale of alcohol were to be permitted from 06.00am until 11.00pm it would seriously impact local residents and more importantly it would put young children at serious risk. We object to the Tesco Stores LTD selling alcohol from 06.00am until 11.00pm on the following grounds:

## 1) Prevention of public nuisance

Due to the location of the Tesco Express we believe there would be serious ramifications for the sale of alcohol from 06.00am until 11.00pm. The Tesco Express is located:

- In a residential area (225 residential units)
- Opposite a park for young children which has several benches to sit on
- Underneath a residential block of flats and is also adjacent to a second block of flats and semi-detached houses

If we were to allow Tesco Express to start selling alcohol you will be putting the residents at risk of:

- Noise pollution
- Vandalism
- Litter and environmental damage
- Sleep disturbance

On the Government website (<u>https://www.gov.uk/alcohol-licensing#community-involvement-in-licensing</u>) it states that anyone who is licensed to sell alcohol will need to take responsibility for the sale and supply of alcohol due to the *"impact"* it has *"on the wider community, on crime and disorder, and antisocial behaviour."* It is clear that the sale of alcohol will have a dramatic impact on our community

which is built up of mainly young families and professional workers. Tesco Stores LTD should be limited in the hours in which they should sell alcohol in a family orientated development – we want to maintain peace and social order.

In the planning permission application (Ref No 11/00835/var) that CALA Ventures Limited submitted, Watford Council made stipulations that Tesco Stores LTD were limited in the hours they were allowed to deliver goods to the store. The reasons you restricted their delivery hours were due to the *"interests of appearance of the site and the locality and the amenities of adjoining residential occupiers"*. As a Council you clearly had the compassion and understanding to realise that delivery hours and waste would affect the residents and the aesthetics of the area. It is imperative you make the same judicious decision to also restrict when Tesco Stores LTD should sell alcohol for the "interests of appearance" as well as the "residential occupiers" of Nascot Grange and the surrounding areas.

In the vicinity of Nascot Wood there are already enough pubs and off licences that sell alcohol. The typical hours for sale of alcohol in Watford are from 10.00am until 11.00pm. In the Nascot Wood/Cassiobury area the Essex Arms and Southern Cross pubs open from midday until 11.00pm. The Express Food Centre (off licence) at the end of Langley Road opens from midday until midnight – why should Tesco Stores LTD be allowed to have extended hours when the remainder of the local shops are not permitted to do so? It is not in keeping with the local area and it would set a precedent for other off licences to apply for extended hours to sell alcohol.

As residents we will be able to tell you of the number of street drinkers that haunt St Albans road and Langley road. These people buy alcohol and then sit on the benches to then consume it. We believe this issue will be exacerbated if street drinkers are allowed to commence their drinking from 06.00am in our area. A recent Meeting of the Community Safety Partnership Task Group, Monday, 30th January, 2012 7.00 pm (Item 13) reported that the way to deal with the problem of street drinkers was to deal with the *"outlets which sold them alcohol"*. Surely, the inexperience of Tesco Stores LTD in dealing with this community issue would increase the problem of street drinkers obtaining alcohol in the area? Not only this, the sale of alcohol from 06.00am would legitimise the street drinkers rights to buy alcohol at any time they want – Tesco Express would have no obligation to stop or deter them. The fact that Tesco Stores LTD have applied for a licence to commence at 06.00am, in our opinion, means they have not regarded the impact it will have on our community. It is purely for their profits and convenience.

## 2) Prevention of harm to children

One of the perks and beauty of the development was the park area which CALA Ventures Limited has spent a lot of money on landscaping. We do not think it is acceptable that anyone is able to buy alcohol before 09.00am and then be able to

use the play area, which has several benches and shaded area, to potentially drink in relative comfort; to allow anyone to have the potential to drink from 06.00am near a play area is not only disturbing but morally incomprehensible and indefensible.

We have already started to see people, who do not live on the Nascot Grange estate, use the park area to drink during the day and the Tesco Stores LTD is not even open. We do not want street drinkers and fear to be a feature of our community and we believe it will become worse if alcohol can be served at the proposed times. Moreover, who will be responsible for the safety of residents and children? Tesco Stores LTD cannot be held accountable for the actions of their customers even if it is proven they have bought alcohol from their premises. We need to put our priorities in order and put in place an acceptable boundary for our community in order to preserve and protect it. Buying alcohol from 06.00am is not only unnecessary but encourages the drinking of alcohol at unsociable times and in the vicinity of vulnerable adults and children.

## 3) Prevention of crime and disorder

It is clear that Watford Council have made decisions to improve areas which have been severely affected by street drinkers, anti-social behaviour and drug users. We recall the objections that were raised on Queen's Road (Error! Hyperlink reference not valid.) and how the Council took steps to reduce crime in the area. Watford Council must now take steps to ensure that the sale of alcohol is limited so that the Nascot Grange development does not encourage crime to take place in an area which is meant for residents, in particular young children. If you allow alcohol to be sold from 06.00am until 11.00pm it will encourage:

- Crime
- Vandalism
- Anti-social behaviour
- Harassment

In conclusion, as residents we do not object to the sale of alcohol. However, it is clear that the sale of alcohol from 06.00am is not in keeping with the opening hours of other local stores in Nascot Wood and is grossly irresponsible due to the location of the Tesco Stores LTD opposite a play area.

It is up to Watford Council to protect the needs of the residents as well as the environment of this area. To allow the sale of alcohol from 06.00am until 11.00pm will encourage street drinkers, crime and anti-social behaviour in what should be a sophisticated, peaceful and aesthetically pleasing area. It is the Council's responsibility to decide what is acceptable and I hope that the decision is made with common sense and for the common good of the residents of Nascot Grange.

Following the letter from Mark Watkin of the Liberal Democrats on the above matter, I would like for you to note my comments below:

While I understand the right for those above the required legal age to purchase and consume alcohol and while I do not specifically seek to impede their right to the reasonable consumption of such products, I am extremely concerned at Tesco's application for a license to sell alcohol that purports to permit the sale of alcohol between the times of 6 a.m. to 11 p.m.

I find this application to be an abhorrent abuse of process that is prima facie inspired by nothing less than an absolute pecuniary interest.

It is imperative in your decision making that you consider the affluence of Nascot Grange and the surrounding areas; upon appercu of the Nascot Grange development, it is transparent that this is a very family friendly area, with almost all dwellings having at least 1 or more young children occupying part of the dwellings. Under the Environmental Protection Act, we have the right to enjoy a peaceful life and existance without the occurence of persistant nuisances.

Opening a Tesco with a license for such lengthy hours serves only to encourage those who wish to abuse this freedom to create a nusiance that is likely to fall foul of Section 79 (1) (h) of the said Act.

"It shall be a duty of every local authority to cause its area to be inspected from time to time to detect any statutory nuisances which ought to be dealt with under section 80......"

Allowing alcohol to be served for such periods of time as intended will simply permit those in our society to behave in a less responsible way and potentially cause a nuisance to residents and harm to young children.

Each of us have a duty to protect our environment and ensure that no harm comes to young children. Allowing people to purchase alcohol in an area where they can easily cause a nuisance and allow them to potentially become so inebriated that they

act in ways that cause harm or offence to others must not be allowed to subsist.

If we apply the commonly recognised legal principal of proportionality, in asking for you to reduce the licensing hours, this must be considered as a reasonable request given that there are sufficient alternative local options for those that want to purchase alcohol outside of the permitted hours.

Why should any mother or father feel intimidated to walk their children to school or fear that an unruly person drinking alcohol (or having recently consumed the same) may attack them verbally or physically? Young children will be scared to play by the park or around the development and they will grow up with what is undoubtedly an influence that is detrimental to their well-being.

I would be grateful if you consider my views favourably as they are views that I am unequivocally confident reflect those of many (if not all) of the residents.

# My objection to the hours requested in Tesco's license application for their new store in Colnhurst Road, Nascot Grange

**Dear Sirs** 

While I welcome the forthcoming opening of the Tesco Express convenience store on the Nascot Grange site, and I have no principal objection to their selling alcohol as virtually every neighbourhood store does these days, I have real concerns about the excessive amount of time each day that Tesco has asked to be able to sell alcohol.

I wish to object because of the potential harm these hours may do to the local community, based on two of the four categories detailed in the Licensing Act.

- 1. Prevention of public nuisance
- 2. Prevention of harm to children

## Prevention of public nuisance

This store is located in the middle of a residential site, with dwellings above it and adjacent to it. I believe there is a very high risk that with its unusually early start when compared with other neighbourhood stores in the area, that it will attract street drinkers looking for somewhere to buy alcohol. Should this occur, it is probable that they will want to consume their alcohol as near as the store as possible and in so doing cause a general nuisance and disturbance to local residents trying to sleep. To avoid this happening, I consider that the store should not start selling alcohol before 09:00 on any day of the week.

Similarly people buying alcohol late at night, particularly after 22:00 can be rowdy and boisterous causing further disturbance to local residents as they try to get to sleep. I request that the store should not be allowed to sell any alcohol after 22:00.

## Prevention of harm to children

## APPENDIX 4 - Z

If the store starts selling alcohol at 06:00 there is a real risk of harm to children. The store is located opposite the very popular playground used by children living in Nascot Grange and others who are en route to the Nascot Wood Schools. If you accept the risk outlined in my previous point, that any street drinkers will be attracted to the benches near to the playground and at the very least will cause distress to the children playing there. Indeed parents may decide to stop their children from using the playground which would be unacceptable. To avoid this happening, the store should not be allowed to start selling alcohol until after 09:00

Based on the above reasons, I request that the Tesco Express licensed hours should be from 09:00 am to 10:00 pm, Monday to Sunday.




