3.0 **DETAILED PROPOSAL**

- 3.1 Call-in and Performance Scrutiny Committee agreed to review Green Spaces at its meeting on 22 November 2007.
- 3.2 The purpose of this review was to assess the delivery of the Green Spaces Strategy against the action plan.
- 3.3 The Scrutiny Committee agreed the final draft of the report at its meeting on 12 March 2008 which was then forwarded to the Executive for consideration.
- At the Call-in and Performance Scrutiny Committee meeting on 9 July 2008 the 3.4 Portfolio Holder attended and responded to the recommendations. The

Scrutiny Committee then reviewed an updated action plan at its meeting on 4 February 2010.
