# THE BOROUGH OF WATFORD (WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2018 (AMENDMENT) (NO. 5) ORDER 2020

#### Watford Council No. 697

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2, 4, 45, 46, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Regulation Act 1991 and Part 6 of the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

- This Order may be cited as THE BOROUGH OF WATFORD (WATFORD)
   (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2018 (AMENDMENT)
   (NO. 5) ORDER 2020 and shall come into operation on (day month) 2020.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
- 4. THE BOROUGH OF WATFORD (WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2018 (the "2018 Order") shall be amended in accordance with the Articles 5 to 14 of this Order.
- 5. Article 2 shall be amended by the addition as follows:-
  - 'Paper Parking Permit' means a permit issued in a paper form,
  - 'Parking Permit' except when used in conjunction with the descriptive terms 'Paper' or 'Virtual' means both a permit in paper form and a permit in virtual form,
- 6. The sides of road referred to in columns 1, 2 and 3 of the Schedule One to this Order shall be added to the parts of Schedules A1, A4, B1 and B3 of the 2018 Order as are indicated in Schedule One to this Order.
- 7. The sides of road referred to in columns 1, 2 and 3 of the Schedule Two to this Order shall be deleted from the parts of Schedules A1, A3, A4, B1, B3 and B15 of the 2018 Order as are indicated in Schedule Two to this Order.
- 8. Schedule Three of this Order shall be added to the 2018 Order as Schedule B21 of that Order.
- 9. Schedule Four of this Order shall be added to the 2018 Order as Schedule A17 of that Order.

- 10. The premises referred to in columns 1, 2, 3 and 4 of Schedule Five to this Order shall be added to Schedule 27: Part One of the 2010 Order as indicated in Schedule Five to this Order.
- 11. The premises referred to in columns 1, 2 and 3 with the types of permit shown in column 4 and the special conditions shown in column 5 of Schedule Six to this Order shall be added to Schedule 27: Part Two of the 2010 Order as indicated in Schedule Six to this Order.
- 12. The Borough of Watford (South Watford) (Prohibition and Restriction of Waiting) (Consolidation) Order 1974 shall be amended by the deletion of all items referring to the south east side of Rosslyn Road.
- 13. The Hertfordshire (Various Roads, Watford) (Restriction of Waiting) Order 2009 shall be amended by the deletion of all items referring to the south east side of Rosslyn Road.
- 14. The Hertfordshire (Rosslyn Road, Watford) (Restriction of Waiting) Order 2012 shall be amended by the deletion of all items referring to the south east side of Rosslyn Road.
- 15. Items in Schedules One and Two of The Borough of Watford (Watford) (Controlled Parking Zones) (Consolidation) Order 2018 (Amendment) (No.6) Order 2020 referring to the east side of Shaftesbury Road are hereby revoked.
