Title: Setting the Council Tax for 2024/25

# 1.0 **Summary**

1.1 This report consolidates the decisions of this Council and the two precepting bodies, Hertfordshire County Council and the Police and Crime Commissioner for Hertfordshire to give the overall Council Tax for residents of Watford for 2024/25.

## 4.0 **Detailed proposal**

- 4.1 Council approved its budget and Council Tax (a 2.99% increase for a Band D property) for 2024/25 at its meeting on 30 January 2024. The Police & Crime Commissioner for Hertfordshire and Hertfordshire County Council have stated the following amounts in precepts issued to the Council, in accordance with Section 40 of the Act, for each of the categories of dwellings shown in paragraph 4.2 below for 2024/25 and the Committee is now required to set the total Council Tax for 2024/25.
- 4.2 The figures for all Council Tax bands for each body are set out in the table below. Having calculated the aggregate in each case, the Council, in accordance with Section 30 (2) of the Local Government Finance Act 1992, hereby sets the following amounts as the amounts of Council Tax for the year 2024/25 for each of the categories of dwellings as outlined below.

4.3 The Police and Crime Commissioner for Hertfordshire agreed a £13 increase (Band D property) in his precept requirement for 2024/25. Hertfordshire County Council agreed a 2.99% increase on its relevant basic amount of council tax and a 2% increase relating to the social care fund for 2024/25.
