On Sunday 25th August 2013, I attended Watford to work as a classic H&M firearms officer as a supporter of the NOTTINGHAM FOREST fans. The match that day was between Watford FC and NOTTINGHAM FOREST. This was a designated football match being played at Vicarage Road Stadium with the KO off the match was 1315 pm.
At approximately 1250 hrs I was on duty with H&M officer P 1511 BALE. We were stood outside the VICARAGE ROAD PUBLIC HOUSE which is located directly outside the entrance of the away fans into the stadium. At this time we received information that NOTTINGHAM FOREST fans had entered the VICARAGE ROAD PUBLIC HOUSE. This a H&M/Watford fans only designated public house.


R 352 ANWARAN SULLIVAN

Upon entering the RGS Con Pub, I immediately identified a group of about 8 males. One of whom I now know to be Neil WACKER. WACKER was at the bar and had alcohol and beer served with alcoholic drinks. WACKER was talking loudly to his group in a broad midlands accent. WACKER and others in his group had tattoos on their arm of NOTION FOREST Club fasci and were clearly identifiable as NOTION FOREST FANS.

I immediately spoke to WACKER and the group and identified myself as a NOTTINGHAMSHIRE police officer. I warned them that they were in a home for only public house. They replied that the door staff had let them in without asking them or checking who they supported. They also added that they had all bought drinks with no problems and that there was no sign on the door or on the pub stating it was a home for only pub.

The group was approached by the landlord of the public house and asked to leave. The group were good natured and quickly finished their drinks and left. They apologised stating they didn't know they had been in the wrong pub.

It is of my opinion that this group would have been clearly identifiable as NOTTINGHAM FOREST fans to door and bar staff at the RGS Con Pub house. Whilst no disorder occurred on this occasion this group's presence could have been enough to spark an anti social disorder or public disorder. This statement is made at 1455 hrs the same day as my original notes and should be referred to as such.

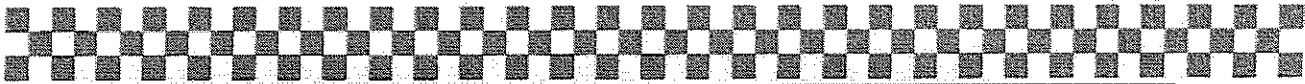


