>Following our conversation this afternoon, I would be grateful if you could clarify the following points in writing and have attached a copy of the application form for change of DPS allegedly signed by yourself on the 23rd May 2013. This application was for you to become DPS of the Red Lion PH and would have been effective from when it was submitted on the 24th May 2013.

>This application means that you are responsible for all offences or issues within the premises from this

date. As disclosed to you there were and we are investigating offences which have occurred since this date.

>From what you have told me, you did not sign this application form and did not give your authority to act as DPS until Monday 27th May? - please confirm this and that you have not seen the attached application form?

>As mentioned due to the historic issues surrounding the premises and the current offences we are investigating the premises will be subject of a review hearing in the near future as well as a criminal investigation in relation to the management of the premises. I have also objected to the application submitted on the 24th May for you to become DPS of the premises - however, as it would appear this was not a valid application if you did not agree or sign it.

>The premises therefore currently has no DPS and is therefore not able to trade any further until as suitable DPS is found and the correct paperwork is submitted.
